**FACT STATEMENT IN CRIMINAL INVESTIGATION**

**START STATEMENT. TIME: 11:17 AM**

My name is Arlo Key. I live at 511 Park Road. I can read, write and understand the English language. On Monday, October 26, 2021, after 2AM. I was driving on Highway 942, about to exit. I was coming directly from a club in a nearby town. I only had two \$1 drinks. I know I can drink more than that. The club let out and I felt real loose. I never felt like that before. I think someone may have slipped me something. I drove my 1997 Chevrolet Cavalier toward home and that's how I was on Highway 942. I think when I was coming down the exit, it was real dark, all of a sudden, bam, he was just there. I realized that it was a person I had hit and he had come through the right front windshield. I was scared and terrified and the car didn't even slow down I was so afraid that I didn't even know what I was doing. I don't even know how I got home. He was on my car and stuck through the right front windshield. I parked my car in the garage and I pulled the garage door down. I stayed in the car and just cried. I talked to the man and he would respond to me. I don't know what he said. I told him over and over that I didn't mean to do this. I wanted to take him to the hospital, but I was so scared. I went to my kitchen floor and just laid there and cried. A little later I went back out to the garage and I began to tell the man how sorry I was. He never responded again. I kept going in and out several times over a few hours telling him I was sorry. I don't know how long the man lived for sure. I called a person named Atlas on Friday. I told Atlas I had hurt somebody and when Atlas went into the garage they fell on the ground crying. Atlas couldn't believe it had happened. I asked what I should do and they said they didn't know. They told me to calm down because I was throwing up. Atlas took me to a friends house – Avery Beasley and then left. Atlas said I've got to go take care of something. Atlas came back later that night with some other person that I've never seen before. I asked them what I should do. They said, "don't worry about it. It's taken care of." I asked if the man was downstairs in their car, Atlas said, "No, he isn't a problem for you anymore." I stayed with Avery for a few days then went home. It was a few days more before I looked in the garage. When I did, the man was gone. I swear to God I wouldn't hurt anyone. I don't want to go to jail.

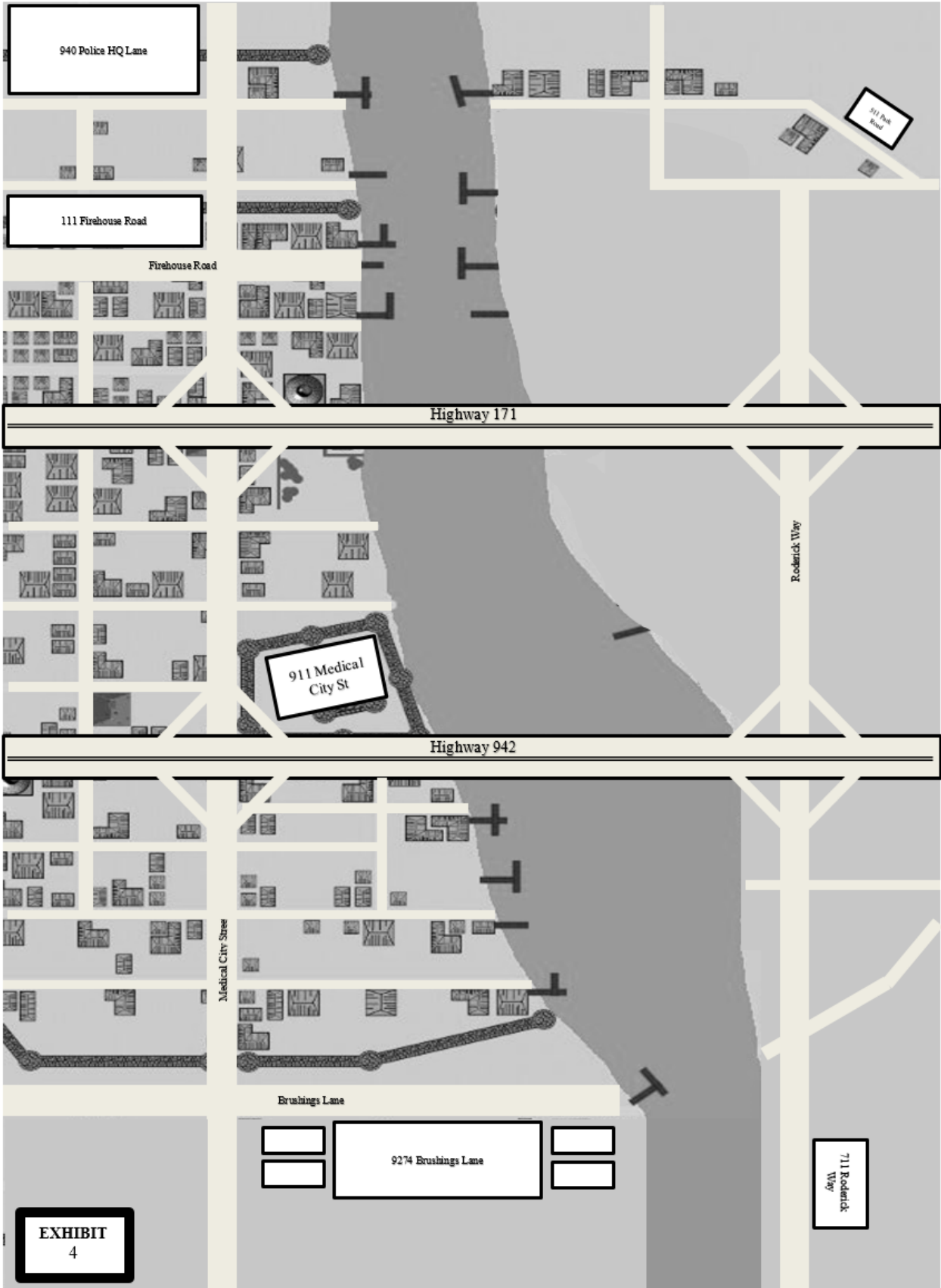
